Municipal waste companies (MWCs) play a critical role in the successful transformation toward more circular practices in European cities. With their established functions, responsibilities, and expertise in local, regional, and supra-regional resource cycles—coupled with decades of experience in circularity—they are uniquely positioned to drive this transition.

To fully realize their potential, MWCs must evolve into real circular economy players and be recognised as such. This involves embracing elaborate R-strategies such as repair, reuse, and resource recovery, tailored to the specific needs of their cities. By tapping into these opportunities and addressing gaps in current practices, MWCs can become reliable drivers of circularity in practically every municipality.

The public nature of MWCs also offers a distinct advantage. Their close connection with local authorities enables them to align with broader sustainability goals and work beyond purely monetary targets. This partnership allows for the development of innovative solutions, strategic initiatives, and a shared vision for circular cities.

In the shift to a circular economy, the municipal waste management sector, alongside other key stakeholders, must develop a new understanding of its role. This includes fostering strategic partnerships, launching innovative initiatives, and defining clear visions and guiding principles. By doing so, MWCs can move beyond traditional waste management to become active enablers—and even drivers—of circular value creation in cities.

Municipal waste companies for circular cities

Municipal waste companies are key players in the transition to a circular economy, but their potential goes far beyond traditional waste management. This community of practice brings together experienced stakeholders from cities and regions working for and with MWCs in a **dynamic working group** to explore how MWCs can become drivers of circular practices in European cities. By joining, you'll get the opportunity to connect with other practitioners, share insights and co-design solutions to the common challenges you face on involving municipal waste companies in the circular cities.

In this community of practice we will

- Collect and analyse best practices from cities on waste and circular economy, discuss why they work and how they can be adapted.
- Explore how municipalities can actively leverage the MWCs potential to support circular initiatives.
- Define the role of MWCs in implementing higher R-strategies such as repair, reuse and resource recovery.
- Discuss why solutions work in some places and how to overcome barriers to scale solutions.
- Promote international networking to share knowledge and collaborate on projects.
- Encourage participants to share their own ideas, challenges and solutions, creating a platform for mutual learning and support on circular economy and the waste management sector.

Join us to shape the future of waste management and drive the transition to a circular economy in your city!

What to expect?

As a member, you'll have the opportunity to tailor the community of practice to your needs and interests, codesigning the structure and activities alongside other participants.

The following outlines some key aspects:

- **Size**: Each group will consist of 5 to 10 cities and regions (with one representative each), supported by experts.
- **Duration**: The community of practice will run for a minimum of 12 months, with the option to extend until December 2026 or beyond, depending on interest.
- **Time Commitment**: Around one day per month, to attend at least five online meetings per year, exchange with peers, and take part in consultations on new materials to support cities and regions.
- Activities: The groups will organize online working meetings focused on the ongoing actions and projects of the participants.
- Outputs: You will work together to produce concrete, publishable deliverables.
- **Funding**: Participation is voluntary, and no funding is available to cover participation costs. There will be no travel required, as all activities will take place online.

- **Learn from your peers**: Gain valuable insights from other cities and regions leveraging circular waste management.
- Find better solutions faster: Collaborate with others to address your needs more effectively.
- Expand your network: Connect with an international community of like-minded partners.

Who can apply?

We invite European local and regional municipal waste companies and related public authorities working closely with the MWCs to apply. This is a unique opportunity to be part of a collaborative network driving impactful change in the circular economy.

Participation will be assessed based on the following criteria:

- **Commitment**: Active engagement is key. As a member, you are expected to actively contribute to discussions, attend meetings, and help shape or review group outputs.
- **Relevant Experience**: We are looking for participants who are already working on circular economy initiatives on municipal waste and can bring valuable insights and experiences to the table.
- Geographical Diversity: To foster a well-rounded exchange, communities of practice aim to include members from a variety of European regions, ensuring a broad perspective on the challenges and solutions in circular economy practices.
