



Join the CCRI community of practice on Cutting consumption-based emissions through circular economy

Traditionally, circular economy policies have focused on reducing waste through repair, reuse, recycling and remanufacturing – lowering resource extraction, creating local jobs, and minimizing environmental impacts. Beyond reducing the material use, these actions also play a crucial role in cutting emissions of cities and regions, especially the consumption-based ones.

But what are the actions with the highest potential of reducing consumption-based emissions? How can local authorities ensure that those are realised by their administrations, citizens and businesses?

Together, we will explore how to maximize the benefits and minimise operational challenges of circular economy actions through real-world examples. Participants will also identify and receive guidance for implementing high-impact actions, ranging from **efficiency (doing more with less)** to **sufficiency (reducing demand)**, in order to reduce their cities' consumption-based emissions.

Cutting consumption-based emissions through circular economy

Our community of practice will bring together urban administrations (environmental, waste, construction, etc.), citizen associations, and circular economy practitioners from European cities or regions to exchange experiences, identify barriers and build solutions to better use circularity to reduce their consumption-based emissions.

We will explore topics such as:

- **Understanding different concepts** around emissions (consumption-based emissions vs carbon footprint vs indirect emissions vs territorial emissions)
- **Auditing** current climate and circular economy actions (and strategic plans)
- Understanding the **role of circular actions** within climate reduction strategies followed by distinguishing and prioritisation for a city
- **Implementation** - case studies, best practices and how-to

The “Reducing consumption-based emissions through circular economy actions” community of practice brings together **experienced cities and regions in a dynamic working group**. By joining, you'll get the opportunity to connect with other practitioners, share insights and co-develop solutions to the common challenges you face in using CE for addressing your climate and material challenges.

What to expect?

As a member, you'll have the opportunity to tailor the community of practice to your needs and interests, co-designing the structure and activities alongside other participants. The following outlines some key aspects:

- **Size:** Each group will consist of 5 to 10 cities and regions (with one representative each), supported by experts.
- **Duration:** Each community will run for a minimum of 12 months, with the option to extend until December 2026 or beyond, depending on interest.

- **Time Commitment:** Around one day per month, to attend at least five online meetings per year, exchange with peers, and take part in consultations on new materials to support cities and regions.
- **Activities:** The groups will organize online working meetings focused on the ongoing actions and projects of the participants.
- **Outputs:** You will work together to produce concrete, publishable deliverables.
- **Funding:** Participation is voluntary, and no funding is available to cover participation costs. There will be no travel required, as all activities will take place online.

- **Learn from your peers:** Gain valuable insights from other cities and regions tackling the same challenges
- **Find better solutions faster:** Collaborate with others to address your needs more effectively
- **Expand your network:** Connect with an international community of like-minded partners

Who can apply?

We invite all European local and regional authorities, along with their agencies and publicly owned companies, to apply. This is a unique opportunity to be part of a collaborative network driving impactful change in the circular economy.

Participation will be assessed based on the following criteria:

- **Commitment:** Active engagement is key. As a member, you are expected to actively contribute to discussions, attend meetings, and help shape or review group outputs.
- **Relevant Experience:** We are looking for participants who are already working on linking circular economy and carbon reduction and can bring valuable insights and experiences to the table.
- **Geographical Diversity:** To foster a well-rounded exchange, communities of practice aim to include members from a variety of European regions, ensuring a broad perspective on the challenges and solutions in circular economy practices.
